Historical & Contemporary Perspective

It was the USVI Charter Yacht Show, under the direction of VIPCA, that first signaled to the global yachting community that the US Virgin Islands were open and ready for charter business—first in the wake of the devastating 2017 hurricanes and again amidst the challenges of the COVID-19 pandemic.

Since then, the territory has experienced remarkable and sustained growth in marine tourism—growth that can be credited to the combined strength of local support and VIPCA's ongoing initiatives, including the continued success of the USVI Charter Yacht Show.

Over the past nine years, VIPCA has steadily elevated the USVI Charter Yacht Show, outperforming neighboring island events in both broker and vessel attendance. The show now draws more than 160 charter brokers from across the globe and features up to 75 exhibiting yachts. These brokers don't just come to view vessels—they come to experience the Virgin Islands firsthand, equipping them to better promote the destination to their clients worldwide. As competition intensifies—especially from nearby markets like the BVI—this type of broker engagement is more important than ever to ensure continued growth and visibility for the USVI's home-based charter businesses.

In 2025, VIPCA is focused on further evolving the USVI Charter Yacht Show to meet the demands of a dynamic and competitive industry. This includes enhancing the show's programming, investing in greater visibility for our sponsors, and continuing to position the Virgin Islands as a destination that moves in rhythm with its natural beauty, culture, and heritage. VIPCA is working year round to benefit the territory

VIPCAs Commitment to the USVI

The Virgin Islands Professional Charter Association (VIPCA) operates year-round as a pivotal organization supporting the marine tourism industry in the U.S. Virgin Islands. Its efforts span advocacy, workforce development, industry standards, and marketing, benefiting both the territory and the private sector. Here's a breakdown of their year-round activities:

Work Force Development and Creating Opportunities for Our Youth:

- VIPCA 2000hr Registered Apprenticeship Program for Virgin Islands Captains with in-job training over 12-months culminating with captains training for USCG license for ages 18+
- VIPCA Marine Apprenticeship intensive 4-week training for ages 18-29 yrs
- VIPCA Junior Sailing Summer Camp 2-week summer program for ages 13-17yrs
- VIPCA Junior After-School Public School Program for ages 13-17yrs
- VIPCA is recognized as an Eligible Service Provider by Department of Labor

Since 2017 VIPCA has graduated 77 students from its Marine Apprenticeship program and 66 from junior programs. We continue to expand our youth training capacity and have celebrated sixteen graduates whom already have been awarded their USCG Captains Licenses, both 50t and 100t, with more booked to take their licenses in 2025. We have a greater than 50% success rate with graduates of VIPCA training programs entering the workforce locally in marine industry careers.


